Deal Report

Lenovo Group, a Hong Kong-listed and China-based manufacturer of computers and computer peripherals, has received \$350 million investment from General Atlantic Partners, Newbridge Capital and Texas Pacific Group. Approximately \$150 million of the funds will be used to finance the acquisition of IBM's PC business. The balance will be added to Lenovo's general working capital and used for general corporate purposes. Upon full conversion, the preferred shares to the investors and the issue of shares to IBM for the acquisition of the PC business, Texas Pacific Group, General Atlantic Partners and Newbridge will own approximately 10.2% of Lenovo's enlarged issued share capital.
